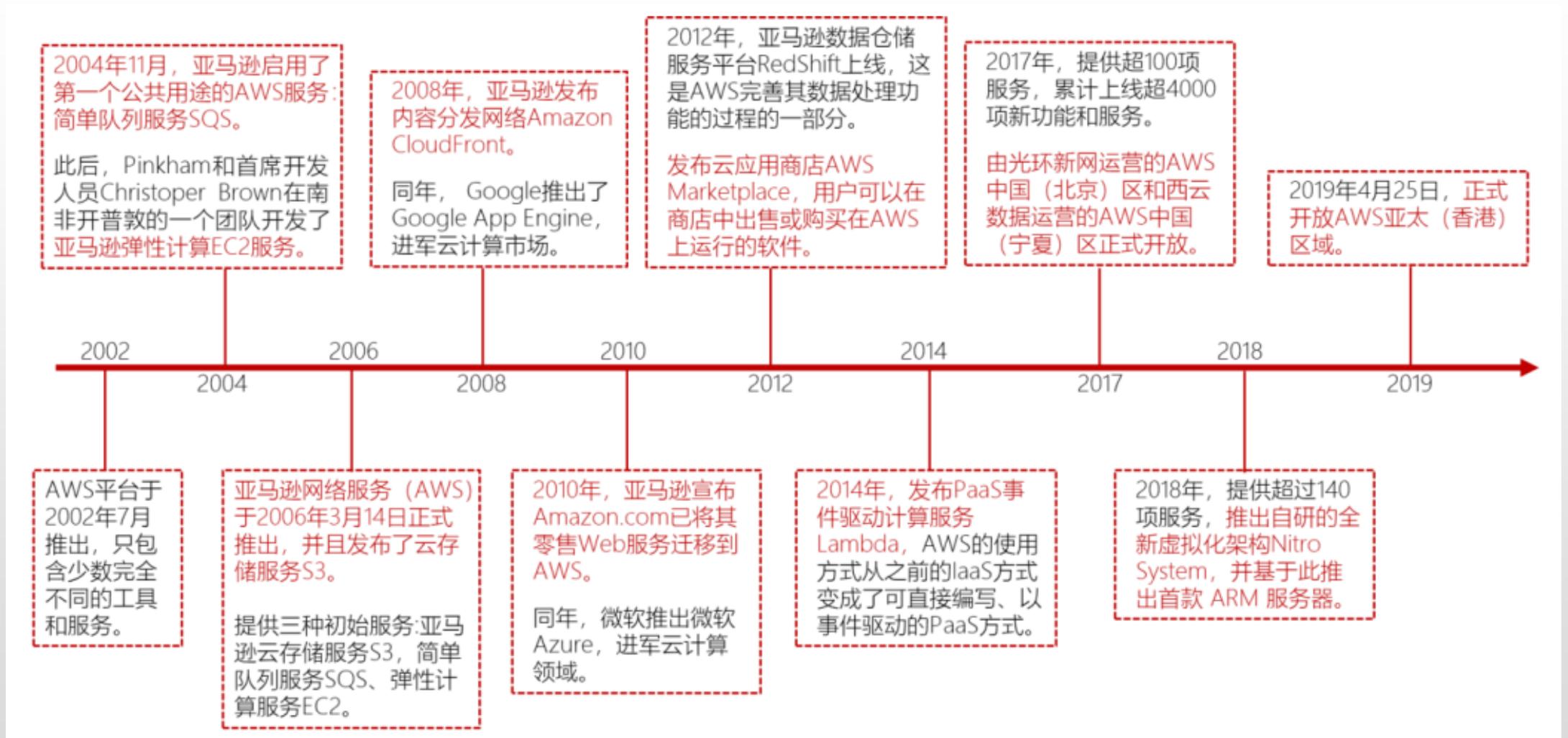

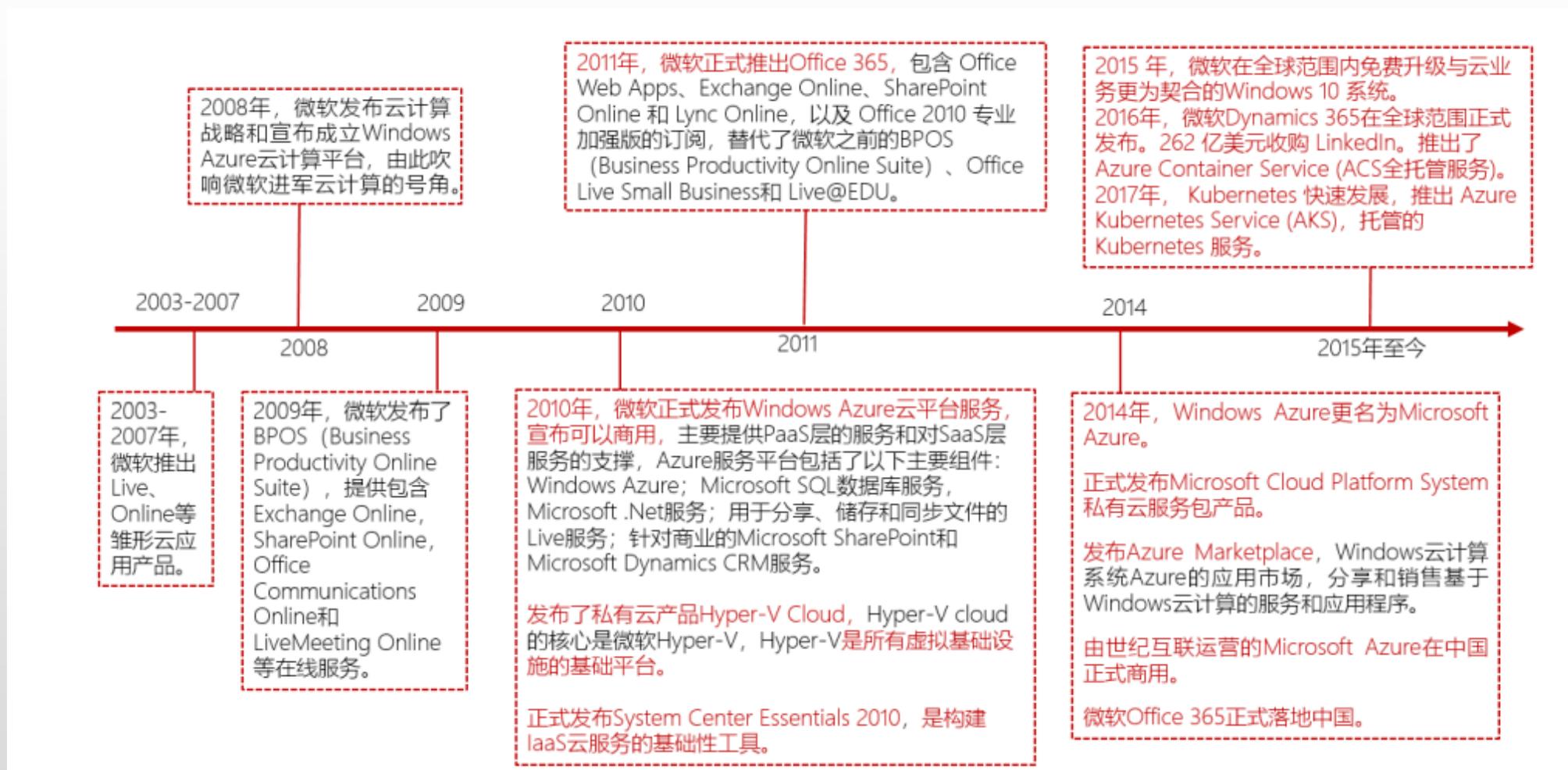

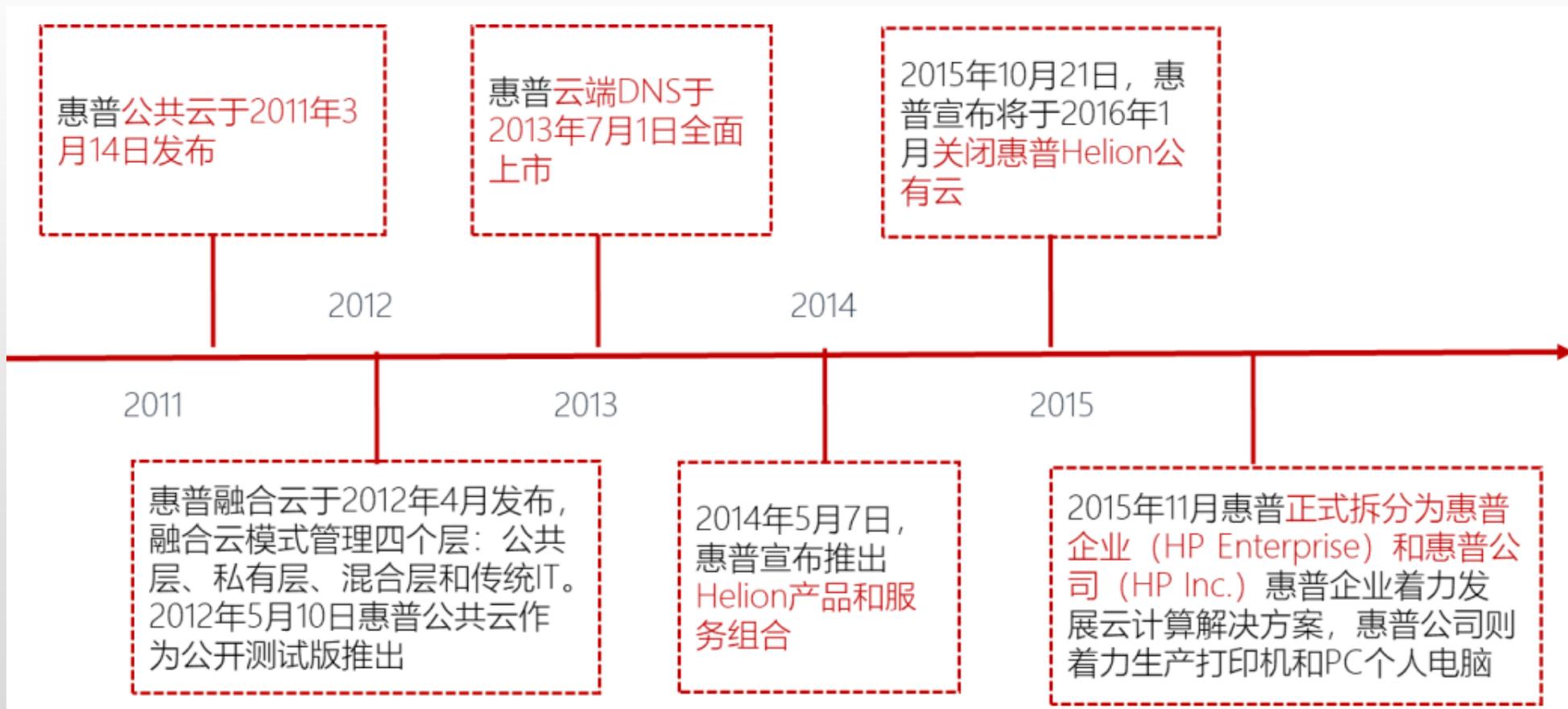
# (软件提供商)Azure:大力布局 SAAS 和 PAAS 服务 为 IAAS 导流

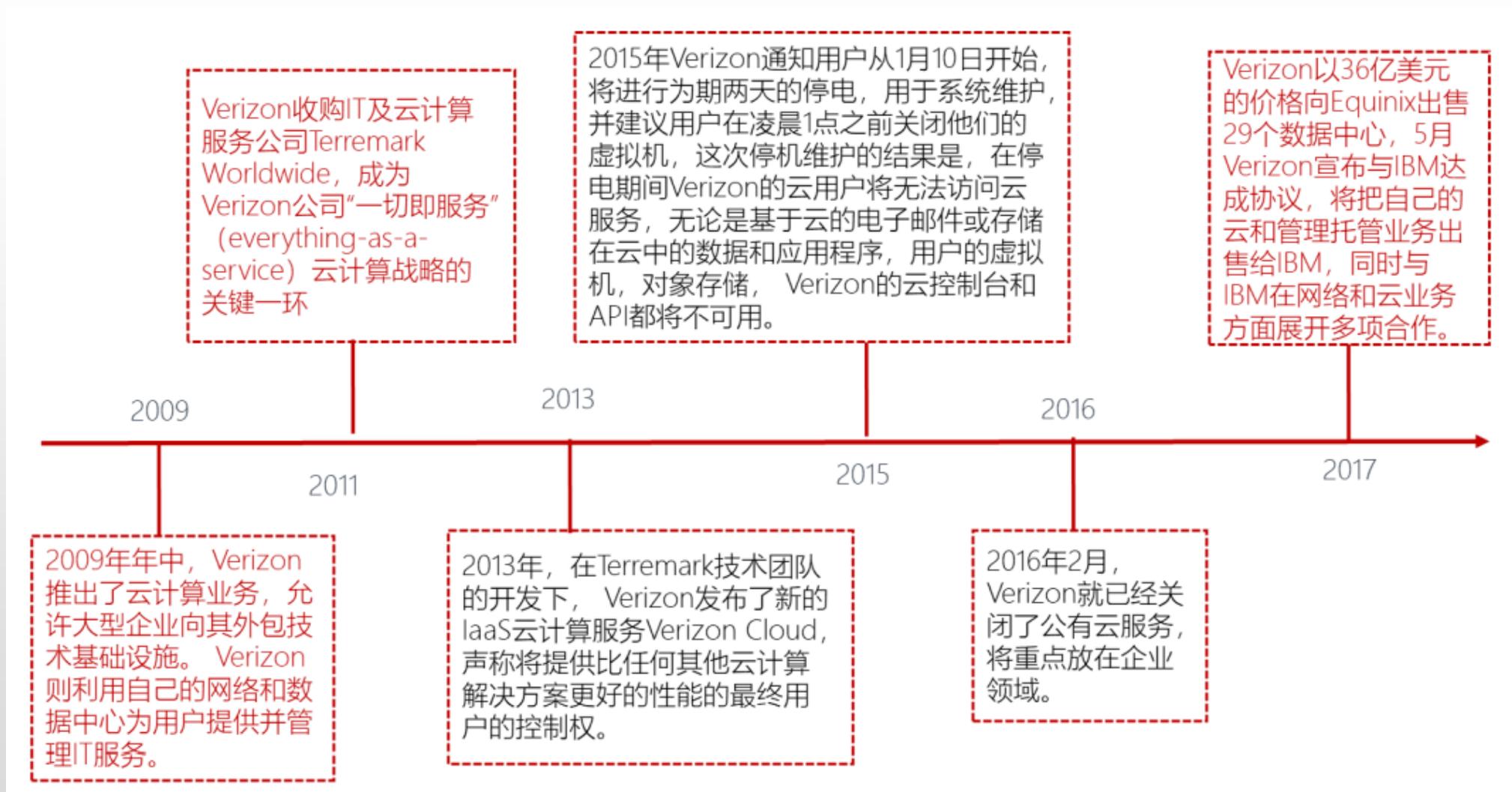
# (设备商)惠普：浅尝辄止云计算，知难而退坚守优势行业

云业务与传统业务“左右手互搏”，进军云市场阻力重重

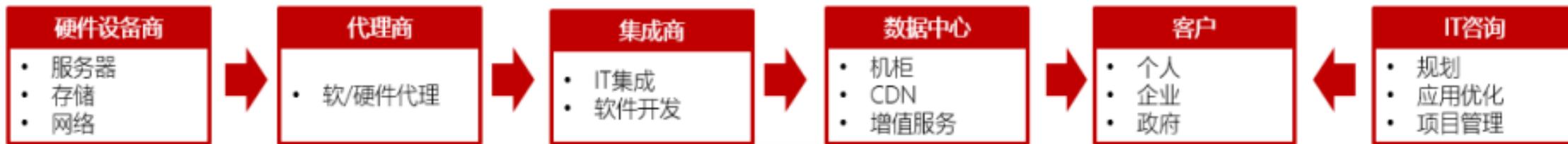
# (运营商)Verizon: 试水云计算, 曲折前行, 高开低走



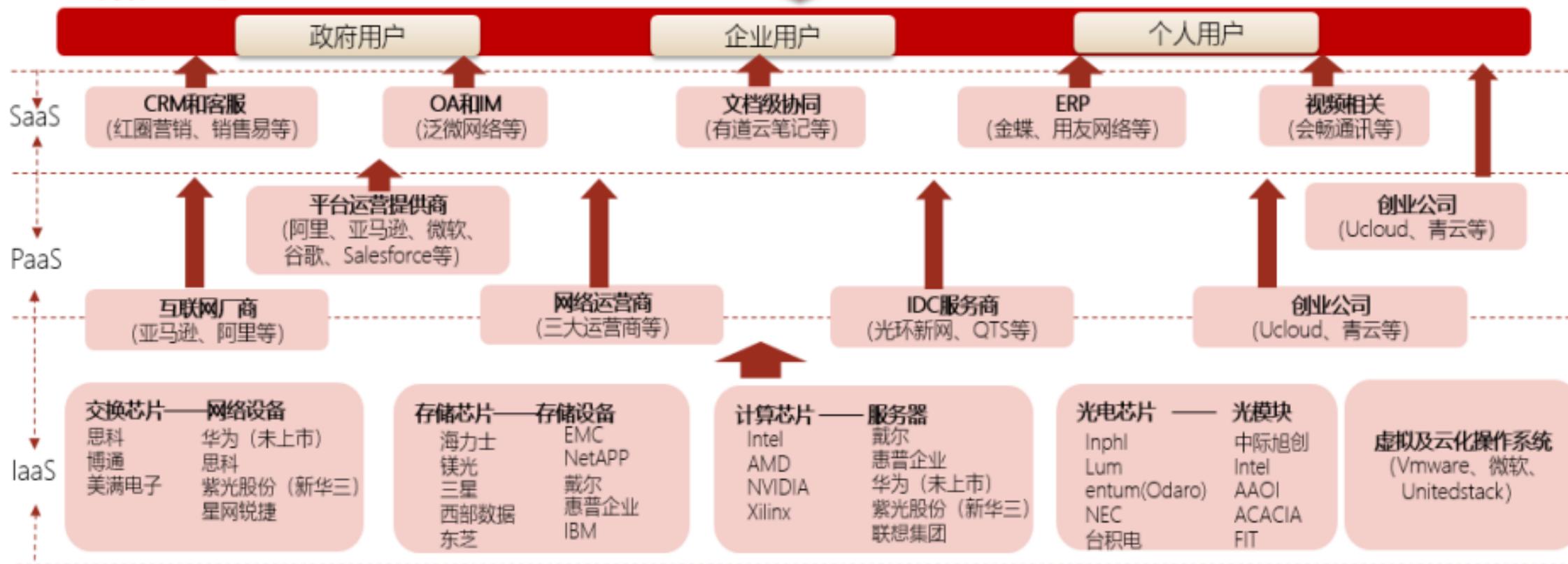

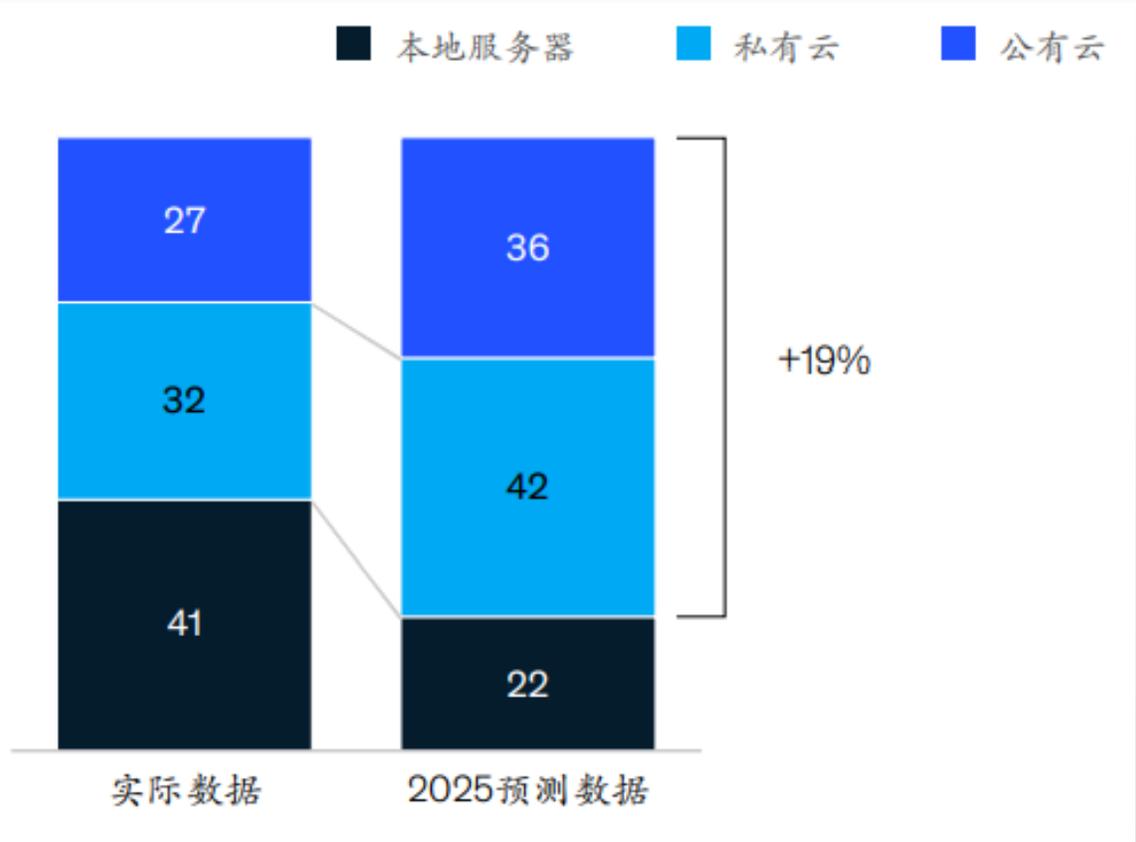
## ■ 传统IT产业链

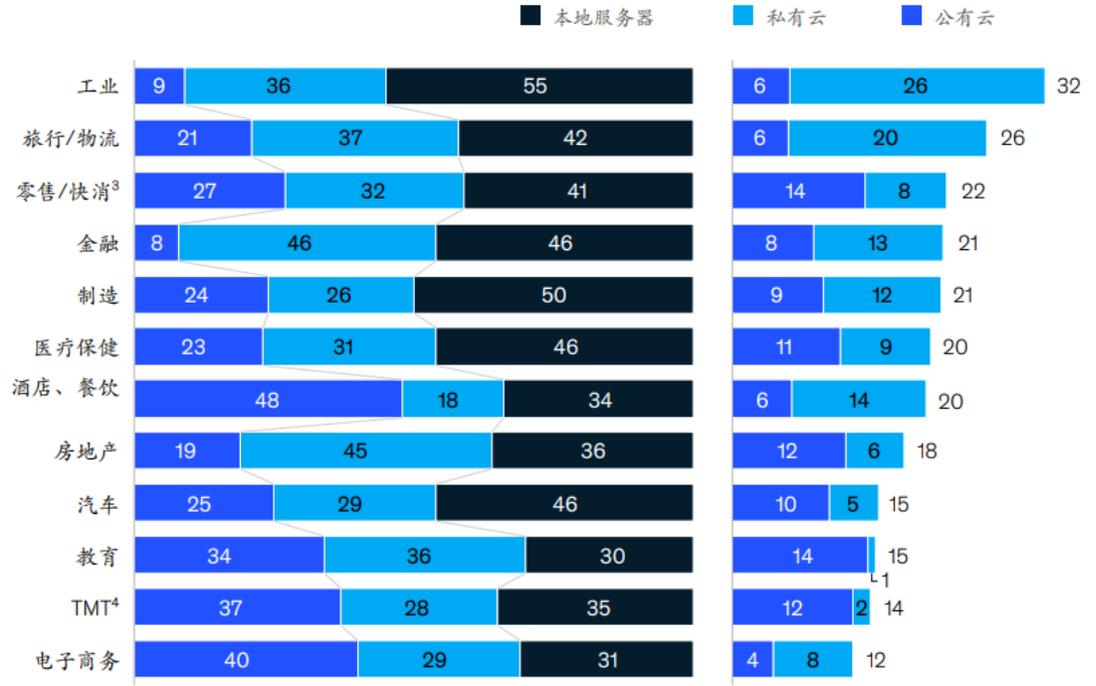


中国市场上私有云仍保持对公有云的优势
